I am pleased to announce that Emerson is joining forces with AspenTech to create an industrial software leader with greater scale, capabilities and technologies to serve the broader needs of customers.

The new software company, which will retain the name of AspenTech, will significantly evolve our software strategy and expand our offerings well beyond our current portfolio. This is an exceptional opportunity, as AspenTech will be a high-performance industrial software leader with the scale and technology to digitally transform the global industrial economy. We expect customers of both Emerson and AspenTech to benefit from enhanced service levels and breakthrough technology as we collaborate to drive faster innovation. **As we discussed at the recent Ovation User Group, we will continue to collaborate with OSI Digital Grid Solutions to deliver end-to-end solutions for the power industry from "generation to the meter."**

Through this transaction, Emerson will own 55% of AspenTech, which will remain an independent, publicly traded company. As part of the transaction, AspenTech will take over ownership of OSI Inc. as well as Emerson's Geological Simulation Software unit. There are several steps remaining to complete this transaction, including the effectiveness of certain SEC filings and the approval of AspenTech shareholders. We expect the transaction to close in the second calendar quarter of 2022.

During this period, it will be business as usual. Existing OSI and AspenTech teams will serve their respective customers with continued dedication to customer service.
